## ΔΕΥΤΕΡΗ ΠΡΟΣΚΛΗΣΗ ΕΚΔΗΛΩΣΗΣ ΕΝΔΙΑΦΕΡΟΝΤΟΣ ΓΙΑ ΤΗΝ ΚΑΛΥΨΗ ΘΕΣΕΩΝ ΝΟΣΗΛΕΥΤΩΝ ΠΡΟΓΡΑΜΜΑΤΟΣ ΣΤΗ ΣΑΜΟ

Ο Ελληνικός Ερυθρός Σταυρός (Ε.Ε.Σ.) απευθύνει **δεύτερη πρόσκληση εκδήλωσης ενδιαφέροντος για την κάλυψη θέσεων Νοσηλευτών Προγράμματος στη Σάμο**, για τις ανάγκες του προγράμματος «Increasing COVID-19 Mobile Testing capacities in Greece» που χρηματοδοτείται από τη DG SANTE/Ευρωπαϊκή Επιτροπή σε συνεργασία με τη Διεθνή Ομοσπονδία Συλλόγων Ερυθρού Σταυρού/Ερυθράς Ημισελήνου (ΔΟΕΣ/IFRC) και υλοποιείται από τον ΕΕΣ. Το πρόγραμμα αφορά στη διενέργεια τεστ ταχείας ανίχνευσης αντιγόνου COVID-19 σε στοχευμένες ομάδες πληθυσμού (μετανάστες και πρόσφυγες σε όλη την Ελλάδα, ΡΟΜΑ και άστεγους στην Αττική).

Οι Νοσηλευτές θα εργαστούν στην Κινητή Ομάδα Διενέργειας Τεστ του ΕΕΣ για διάστημα 6 μηνών, με καθεστώς πλήρους απασχόλησης και θα υπογράψουν ατομική σύμβαση εργασίας στο πλαίσιο του προαναφερόμενου προγράμματος. Η βάση εργασίας για τους δύο νοσηλευτές θα είναι η Σάμος, αλλά θα πρέπει να καλύπτουν επιχειρησιακές περιοχές και σε άλλες Περιφέρειες/Περιφερειακές Ενότητες, σύμφωνα με τις ανάγκες του προγράμματος. Η μετακίνηση θα γίνεται με υπηρεσιακά αυτοκίνητα ή/και μέσα μαζικής μεταφοράς, θα καλύπτεται η διανυκτέρευση και θα παρέχεται η προβλεπόμενη εκτός έδρας αποζημίωση. Σε περίπτωση μη εντοπιότητας των υποψηφίων, θα καλυφθεί το κόστος διαμονής στη Σάμο.

### Summary statement

Given the increasing spread of the COVID-19 epidemic in Greece, Hellenic Red Cross (HRC) is following a comprehensive COVID-19 Response Plan, within Red Cross Movement general epidemic response, aiming to support the mitigation of the virus spread and the health, social and economic impact of the epidemic on vulnerable population and/or communities. The project “Increasing COVID-19 Mobile Testing capacities in Greece”, is funded by DG SANTE, in agreement with International Federation of the Red Cross/Red Crescent (IFRC) and HRC is the implementing partner.

The nurse of the “Increasing COVID-19 Mobile Testing capacities in Greece” project, under the direction of the Head Director of Health Sector and the project coordinator, will have the responsibility of ensuring that the project is implemented efficiently in the targeted sites in various geographical locations, according to project requirements and protocols on covid-19 testing. The project nurse will work as part of a team consisting of staff and volunteers, and in collaboration with relevant HRC Departments, within the scope of the project and the mandate of the Hellenic Red Cross and the IFRC.

### Key tasks and responsibilities

- Collect (swabbing), handle and test specimens from the targeted population in designated sites, according to project requirements and specifications of the COVID-19 antigen rapid test, to screen for COVID 19 infection
- Support the organisation and coordination of the testing operation in each targeted site in various geographical locations, and ensure that all of its phases are completed as per project guidelines
- Take all necessary measures to avoid contamination of specimens and prepare appropriately the specimens due for lab (PCR) testing
- Ensure that all necessary measures are followed to avoid potential spread of the virus among the members of the HRC testing team and among the population
- Ensure tests are logged and tracked according to set procedure and all necessary data collection and recording is done according to agreed protocols and project guidelines, and are adhering to the requirements of the data protection regulation
- Maintain accurate files and records, both electronic and manual, for each site
- Follow the project protocol regarding the management of the test results
- Ensure that testing related report is sent in a timely manner to all agreed recipients and provide the necessary reporting (eg weekly, daily) to HRC HQs

- Regularly provide (requested and non-requested) insight regarding the project implementation status, and ensure that the project coordinator & manager are timely informed of variances
- Provide the HRC project team at HQs with information and guidance on project performance per site
- Frequently monitor the inventory records of all necessary supplies and make timely supply requests to HQs, to ensure that adequate quantities are available in the field to perform each testing exercise
- Ensure that all the supporting documents for reporting are made available according to donor requirements and as per project management procedures
- Other duties as assigned, if needed
